WE WERE SUPPOSED TO HAVE COME IN SECOND Hamit Weigel 1979 marks the 29th year of the IEEE Treasure Hunt in the Valley. The prizes awarded winners over the years have had little monetary value, yet the competition for first place has become keener each year. The excitement has grown, and the red hunting caps awarded Treasure Hunt winners have become the prized possession in many a trophy cabinet. Wearing this red crown of victory accords winners the privilege (and responsibility) of serving a three-year term on the Treasure Hunt Committee - trying to stump their cohorts.

Beginning in 1970 all two-time winners with six years of committee service, or one-time winners who have had less than three years of respite from committee service, have been offered the opportunity to declare their car "professional". This must be done upon application for tickets to the hunt.

Because of experience gained since 1970, in administering the 1970 "pro" resolution, the committee has made the following interpretation of the resolution. This is being done to define in detail how the resolution should be administered and to avoid confusing situations which have occurred or might occur.

A professional team agrees not to compete against amateur teams in the hunt. First, second, and third place prizes will be awarded to the three amateur teams with the lowest times per clue. If a professional team has the lowest time per clue for the hunt, the accomplishment will be announced, and the team members which qualify the team for "pro" status will be awarded "PRO" buttons to be affixed to their previously—won red hats. In addition, this team will be admitted to the new "ProButton Winners" section of the Hall of Fame. Other pro teams which have times per clue lower than the third place winners will be announced for their respectable showing. Pro teams which ran near the end of the pack will also be announced in order to give encouragement to the novice first year teams which have participated.

Of course, eligible hunters who chose not to be declared "professional" for a hunt will compete and be eligible for first, second, or third place. Also, if this choice is made and the team helps bring up the rear, they will be left alone to hide at their dark corner table behind their beer pitchers where they need not fear the announcement of their boondoggle.

Through the years many couples who are not IEEE members have served on the committee. They have contributed significantly in making the Treasure Hunt the success that it has been over the past 28 years. Because of this, non-member couples who have served on the committee are given the same status as member couples when ticket preference is given. Of course, non-member ticket prices must still be paid by these couples.

"I'm so mad about these clues. Just wait until I talk to the TH committee. I can't wait to hear what they have to say about these. They can't get away with this. The sooner I talk to them the better. This is ridiculous.

IF YOU ARE UNABLE TO SOLVE THIS CLUE OR TO FIND CLUE B, OPEN EMERGENCY SOLUTION ENVELOPE 3, WHICH WILL DIRECT YOU TO CLUE B.

So you can't wait to talk to the committee! Well, just call them! The phone number is on the map, so call and you will be told to go to Circle 32.

Go to Circle 32. The clue is located near Bell Road at 7th Street. Go 0.13 miles south of Bell on 7th St., to a dirt trail just south of a power pole. Go 194 feet east on the dirt trail, where it will intersect another dirt trail. Go 280 feet south to a Palo Verde tree on the west side of the trail. The clue is behind the tree.

IF YOU ARE UNABLE TO LOCATE CLUE B, OPEN EMERGENCY SOLUTION ENVELOPE 8, WHICH WILL DIRECT YOU TO CLUE C.

This clue was a visual consisting of a hot dog (or frankfurter) in a beer mug (or stein). With Halloween fresh in mind, the astute hunter will head for the hiding place of FRANK-IN-STEIN, at Circle 47, near Monsterous Wash.

Go to Circle 47. The clue is near Thunderbird Road between 7th and 18th Streets. Go 0.8 miles west of 18th Street on Thunderbird. Look for the corner of a fence on the south side of Thunderbird. From the corner of the fence, walk 150 feet southwest along the fence, to a deep wash. The clue is located on the north bank of the wash, 25 feet east of the fence, under a catclaw tree.

IF YOU ARE UNABLE TO LOCATE CLUE C, OPEN EMERGENCY SOLUTION ENVELOPE 13, WHICH WILL LEAD YOU TO CLUE D.

This is Clue C. Solving this clue will direct you to Clue D.

Three bugs are placed on a flat surface with no obstructions, each bug exactly eight feet away from the other two bugs. The bugs are trained so that bug A always follows bug B, bug B always follows bug C, and bug C always follows bug A. Each bug travels at a speed of one inch per second. At t=0, the bugs start out from their initial positions. How many inches does each bug travel before they catch each other?

If you are unable to solve this clue or to find Clue D, open emergency solution envelope 13, which will direct you to Clue D.

The solution to this problem is much easier than you might expect. Even though the bugs will spiral in toward the center, at any instant, the bugs form an equilateral triangle. Thus, their relative velocity toward each other is constant and is 1 + COS 60° inches per second, or 1½ inches per second. Since they started 96 inches apart, it takes exactly 64 seconds for them to meet, and thus each bug must have traveled 64 inches. So go off to circle 64.



Circle 64 is located near 32nd St and Acoma. From Acoma go south for 0.135 miles to a dirt trail heading northwest from 32nd St. Go northwest up the dirt trail for 180 feet. Clue D is located 20 feet north of trail, on the west side of some bushes.

If you are unable to locate Clue D, open emergency solution envelope 1 which will direct you to Clue E_{\bullet}

All you circuit designers will recognize the op. amp and resistors as a summing circuit (or adder). The input and output capacitors may seem a little strange to you, however, and they should, because this is not really a circuit but a pf-adder (puff adder). So slither off to circle 91, at the snake pit.

From the corner of Tatum Blvd. and Union Hills, go north on the dirt trail 0.2 miles north of the CAP bridge to some palo verde trees. Walk east 160 feet to the base of the dike. Clue E is near the base of the dike, behind a small tree.

If you are unable to locate clue E, open emergency solution envelope 20 which will lead you to clue F.

Clue E was a visual clue consisting of a picture of a colorful flower garden and butterflies.

Did you tiptoe through the tulips to look for a hidden number? Good idea: but try the red cellophane from your brown bag and scan the butterflies fluttering around. The number 60 will be seen on one of the butterflies.

Circle 60 is located near 20th St. and Union Hills Drive. From Union Hills and 20th St., go north 0.22 mi. to a dirt T - intersection. The clue is located behind a Palo Verde, 45 ft. directly north of the intersection.

If you are unable to locate Clue F, open emergency solution envelope 7 which will direct you to Clue G.

IF YOU ARE UNABLE TO LOCATE CLUE G, OPEN EMERGENCY SOLUTION ENVELOPE 24, WHICH WILL DIRECT YOU TO CLUE H.

If you are unable to solve this clue or find Clue H, open emergency solution envelope 24 which will direct you to Clue H.



Clue H is located at Circle 3, near the intersection of Thunderbird and 64th Street. From the corner of Thunderbird and 64th Street, go north on 64th St 0.5 miles to the end of the pavement. Proceed north on dirt trail for 0.28 miles to a fork in the trail. The clue is located behind a tree 100 feet north of the fork, 25 feet west of the trail.

If you are unable to located Clue H, open emergency solution envelope 53 which will direct you to Clue I.

THIS IS CLUE H. SOLVING THIS CLUE WILL LEAD YOU TO CLUE I.



Clue H is a visual clue consisting of a campfire with a sheet of charred aluminum foil draped over it.

Circle 46 is located near Scottsdale Rd. and Greenway. From Scottsdale Rd. go East on Greenway for 0.65 mi. Go North on the dirt road for 0.2 mi. Clue I is located 105 ft. West of the read under a palo verde tree next to a small wash.

If you are unable to locate Clue I open emergency solution envelope 16 which will direct you to Clue J.

This is Clue I. Solving this clue will direct you to Clue J.


If you are unable to solve this clue or to find Clue J, open emergency solution envelope 16, which will direct you to Clue J.

This clue can be solved mathematically by writing the equations and solving for the integer solutions, but this problem turns out fairly easy to solve by simple trial and error. The answer is 19 (hope you didn't forget the two cookies Mom ate!), so off to circle 19.

Circle 19 is near Pima Road and Sweetwater Avenue. Go east of Pima on Sweetwater for 0.28 miles until the pavement ends. (it turns south into a private drive.) From this point continue east along the fence line for 0.2 miles until it intersects a wash. Clue J is located 75 feet north of the road in the center of the wash.

If you are unable to locate Clue J, open emergency solution envelope 9 which will lead you to Clue K.



Clue J was a visual consisting of two X's, one is clean and one is dirty. With them was a sign saying, "the choice is yours but don't blow it."

Circle 15 is near Cholla and 108th. St. The clue is located in a wash which is 130 feet south of Cholla. Go 137 feet northeast from 108th. in the wash. The clue is located at the base of a large mesquite tree.

IF YOU ARE UNABLE TO LOCATE CLUE K, OPEN EMERGENCY SOLUTION ENVELOPE 22 WHICH WILL LEAD YOU TO CLUE L.

This is Clue K. Solving this clue will direct you to Clue L.

If you are unable to solve this clue or to find Clue L, open emergency solution envelope 22, which will direct you to Clue L.

Maybe since the problem was upside down, the answer is upside down! Turn your calculator upside down and it spells hole, so go to circle 14 on the map where it says hole.

Circle 14 is near Shea Blvd and Scottsdale Rd. Go north from Shea in the alley behind the stores on the north west cerner of Shea and Scottsdale Rd for 0.1 miles. The alley is located 75 feet west of 71st Place. The clue is located 82 feet west of the alley under a palo verde tree.

If you are unable to locate Clue L, open emergency solution envelope 33 which will direct you to Clue M_{\bullet}

PUNISHMENT

If you are unable to solve this clue or to find Clue M, open emergency solution envelope 33 which will lead you to Clue M.

This is emergency solution 33 which will lead you to Clue M.

The large letters are not just for effect. They are capital letters for CAPITAL PUNISHMENT! On the map you will notice various forms of punishment but only one is capital punishment. Located at the HANGING WASH, circle 9.

Clue M is located at circle 9. From the intersection of Scottsdale Rd. and Bell Rd., proceed north 0.63 miles. Turn west on a dirt road, following this road for a distance of 0.22 miles until you come to a fence corner. The clue is located in a deep wash under a Palo Verde tree 135 feet south of the road.

If you are unable to locate Clue M, open emergency solution envelope 35 which will lead you to Clue N.



Clue M was a visual clue consisting of an Orange Crush can fastened to a post.

IF YOU ARE UNABLE TO SOLVE THIS CLUE, OR TO FIND CLUE N, OPEN EMERGENCY SOLUTION ENVELOPE 35, WHICH WILL LEAD YOU TO CLUE N.

This clue should be a gift to those veteran hunters who are looking for a football clue every year. Any fan of the Denver Broncos quickly recalled the ORANGE CRUSH defensive line and hurried off to Circle 230 on Bronco Trail.

Go to Circle 230. From the intersection of Pima and Happy Valley Roads, go 0.5 miles west to Ranch Gate Road. Turn right and follow Ranch Gate Rd. north for 0.5 miles to Bronco Trail. Turn right and proceed for 0.125 miles, where Bronco Trail ends in a cul de sac. The clue is located behind a large Palo Verde tree 200 feet north of the center of the cul de sac.

IF YOU ARE UNABLE TO LOCATE CLUE N, OPEN EMERGENCY SOLUTION ENVELOPE 2, WHICH WILL LEAD YOU TO CLUE O.

This is Clue N. Solving this clue will direct you to Clue O.

The parade was passing the judges stand when at that moment one of the spectators ran in front of a trumpet player, shoving the trumpet deep into the musician's throat. If you are unable to solve this clue or to find Clue O, open emergency solution envelope 2 which will direct you to Clue O.



Go 0.1 miles north of Jomax Road on Pima Road. Turn west (left) and continue for 0.1 miles to where a large water tank is enclosed in a fenced area. From the Southeast corner of the fence, go 92 feet southwest to an Ironwood tree. The clue is behind the tree.

If you are unable to locate Clue O, open emergency solution envelope 12 which will direct you to Clue P.

This is Clue 0. Solving this clue will direct you to Clue P.



This was a visual clue consisting of a post on which was printed, "Clue O", with an arrow pointing to the top of the post.

If you are unable to solve this clue or to find Clue P, open emergency solution envelope 12 which will direct you to Clue P.

This is emergency solution 12 which will direct you to Clue P.


The committee decided to check out your sense of smell on this clue. If you examined the post carefully, you would have determined that the top of the post had been soaked in after shave lotion (or did you think it was one of your team members?). So off you go to circle 196 on Aftersh Ave.

Circle 196 is located west of Scottsdale Rd. between Mappy Valley Rd. and Jomax Rd. along the transmission line road. Go west 0.2 miles along the transmission line road until you come to the first tower. From the center of the road, walk directly north 300 feet through the center of both towers. The clue is located under a mesquite tree.

If you are unable to locate clue P, open emergency solution envelope 21 which will lead you to Clue Q.

This is Clue P. Solving this clue will lead you to Clue Q.


This clue was straight forward enough. However, the carrier was reinserted at the wrong end of the band edge when it was being recovered:

If you are unable to locate Clue Q, open emergency solution envelope 15 which will direct you to Clue R.






