#### THE 38th ANNUAL IEEE TREASURE HUNT

1988 marks the 38th year of the IEEE Treasure Hunt in the Valley. The prizes awarded winners over the years have had little monetary value, yet the competition for first place has become keener each year. The excitement has grown, and the red hunting caps awarded Treasure Hunt winners have become the prized possession in many a trophy cabinet. Wearing this red crown of victory accords winners the privilege (and responsibility) of serving a three-year term on the Treasure Hunt Committee - trying to stump their cohorts.

Beginning in 1970, all two-time winners with six years of committee service, or one-time winners who have had less than three years of respite from committee service, have been offered the opportunity to declare their car "professional". This must be done upon application for tickets to the hunt.

In 1982, the 1970 resolution was amended to limit those teams who wish to declare themselves "professional" to those who have three or more members qualifying as exempt from committee service under the 1970 resolution.

Because of experience gained since 1970 in administering the 1970 "pro" resolution, the committee has made the following interpretation of the resolution: (This is being done to define in detail how the resolution should be administered and to avoid confusing situations which have occurred or might occur.)

A professional team agrees not to compete against amateur teams in the hunt. First, second, and third place prizes will be awarded to the three amateur teams with the lowest times per clue. If a professional team has the lowest time per clue for the hunt, the accomplishment will be announced, and the team members which qualify the team for "pro" status will be awarded "PRO" buttons to be affixed to their previously won red hats. In addition, this team will be admitted to the new "Pro-Button Winners" section of the Hall of Fame. Other pro teams which have times per clue lower than the third place winners will be announced for their respectable showing. Pro teams which ran near the end of the pack will also be announced in order to give encouragement to the novice first year teams which have participated. Beginning in 1985, the novice team with the best time has also been officially recognized, and encouraged to keep up the good work.

Of course, eligible hunters who chose not to be declared "professional" for the hunt will compete and be eligible for first, second, or third place. Also, if this choice is made and the team helps bring up the rear, they will be left alone to hide at their dark corner table behind their beer pitchers where they need not fear the announcement of their boondoggle.

Through the years, many couples who are not IEEE members have served on the committee. They have contributed significantly in making the Treasure Hunt the success that it has been over the past 38 years. Because of this, non-member couples who have served on the committee are given the same status as member couples when ticket preference is given. Of course, non-member ticket prices must still be paid by these couples.




Do what you are told to do, walk 25,000 centimeters (about 835 feet) due east. OR; Drive to Circle J. You will find the answer at either place. One is just a lot closer and quicker.

The first and quickest solution is located 835 feet east of Circle 9. This clue site is marked on the map with an unlabeled arrow and is down a small dirt trail, at the base of a large Saguaro, on the west side of a wash.

The second solution, at Circle J, is located east of Pinnacle Peak Restaurant off Rio Verde Drive. Follow Rio Verde Drive east to 118th Street. Go north on 118th St for 0.23 miles to a cross-road. (Watch for a bad wash at 0.2 miles). The clue site is located 127 feet west and 108 feet north of the intersection, under a palo verde tree on the south side of a wash.




And since there wasn't a 34 on the map, head on over to circle 43.

Circle 43 is located east of Scottsdale Road on Deer Valley Road. From the intersection of Scottsdale and Deer Valley Roads (1 mile south of Pinnacle Peak Road), go east on Deer Valley Road for 0.25 miles to the power sub-station on the north side of the road. The clue is located 48 feet north of the north-northwest corner of the wall around the substation, under a large palo verde tree.

Circle ZZ is located North of the CAP canal, and west of Pima Road. From the intersection of Pima Road and Bell Road, (Note this is the portion of Bell Road which is NORTH of the CAP canal), proceed west on Bell Road for 0.7 miles, to a dirt road going north. Turn north on this dirt road for 0.2 miles, to the corner going back east. The clue is located 60 feet north of the intersection, in a wash, under a palo verde tree.


Then fly on over to circle 69.

Circle 69 is located near the intersection of Pima and Happy Valley Roads. From the intersection of Pima and Happy Valley Road, go west on Happy Valley 0.1 miles to 87th Street, then south on 87th for 0.05 miles to La Junta, then west 0.1 miles to the end of the cul-de-sac. The cluesite is located 170 feet south (170 degrees) relative to the center of the cul-de-sac, by a large palo verde tree.





The clue is located 120 feet north and 180 feet east of the northeast corner of the substation, (or 216 feet at a bearing of 56 degrees) behind a palo verde tree.



Go north for 0.18 miles, to the intersection with another dirt road. The clue is located 90 feet southwest on this intersecting road, and then 60 feet northwest to a palo verde tree.




Most typical silicon diode drops are 0.7 Volts. So take that electrifying info and charge on to Circle 0.7.

Circle 0.7 is located west of Cave Creek Road on Peak View Road. Go west of Cave Creek Rd. on Peak View, across a cattle guard, for just over 1.5 miles, to where the road curves north. Take the most obvious dirt road south from this point for 0.25 miles. The clue is located 135 feet southeast (154 degrees) of the road under a lone palo verde tree.


